Kai Schubert elected as new Chairman, Joachim Hausner and Waldemar Kelm as new members of Münchener Hypothekbank's Supervisory Board

Munich, 17 April 2026 – The Supervisory Board of Münchener Hypothekbank today elected Kai Schubert, a member of the Board of Management of Raiffeisenbank eG (Hagenow), as its Chairman. He has been a member of the Supervisory Board since 2012.

The Delegates Meeting of Münchener Hypothekbank had earlier elected Joachim Hausner and Waldemar Kelm as new members of the Bank's Supervisory Board.
